honor roll smart—and pretty. She was also comical, her mother says, amazingly loyal to her friends and concerned for others—especially the underdog. A senior at Pioneer Valley Regional High School in Northfield, who love-love-loved soccer, Makenzie planned to major in physical education.

Her dreams were cut short by an untimely winter car accident in 2010, but her memory lives on through a Community Foundation scholarship established that year by her mother, Marcy Robitaille. Now, an annual soccer tournament to help fund that scholarship has brought the total up \$15,000 over the two years of its existence. Other fundraisers held by family members or friends help increase the endowment as well.

Makenzie's memory is strong in still another way, as six people are living with an organ donation from Makenzie.

It was a friend's phone call that provided Marcy with the inspiration to set up an athletic scholarship in Makenzie's memory. "It was the perfect fit," she said. "The most important thing to me is that she's remembered. Putting her name out there, it will always be constant. She was getting ready to go to college, filling out all of the applications. After she passed, I found one of the college essays written for an application, entitled "Money Doesn't Grow on Trees." She was a hardworking young lady, and very focused and very committed. She wanted to be a teacher and a coach." The scholarship gives help to students with successful athletic performance at Pioneer Valley Regional. "Because soccer was her love, I felt we needed to gift someone who maybe had a heart for the same sport, or athletics in general," said her mom.

Foundation helps raise \$70,000 through food challenge grant


"Vonderful" and "tremendous" are words Patrick LaPointe uses to describe the Community Foundation's funds management results, which—in this fourth year—yielded Doyle Field a hefty \$62,000 to help maintain the park's facilities. Dedicated by Mayor Bernard W. Doyle in 1931, Doyle Field has become a 22-acre

recreational complex, home to the Wachusett Dirt Dawgs—a new franchise in the Futures Collegiate Baseball League—and also site of a beautifully restored football field that serves as Leominster High School's Blue Devils team home.

Additionally, the park offers fields for other sports, tennis courts and the popular Imagination Station—a playground that's busy all day long, every day. Doyle Field, straddling Priest Street in central Leominster, is also a favorite walking area.

Maintaining several fields with all of their associated buildings and facilities, however, is no minor expense. Grants help, and the Doyle Field Foundation raises funds continually for expansion, replacement and repair. LaPointe cites former Mayor Doyle and his daughter, Louise, for a \$1 million endowment that remains in place to assist maintenance issues without draining city coffers. It is the second of two \$1 million endowments from the Doyles over the years.

LaPointe, Doyle Field coordinator and retired DPW director, says a renovation project, started in 2005, is ongoing. Funds from the endowment go toward repairs,



freeing up other funding for growth projects. This year, they'll replace sub-standard bleachers in the baseball area, add fencing and concrete under-padding to bring them up to code, and finish installing fencing along the field, among other projects. 10 food pantries. To help replenish food pantries after a busy winter, the Community Foundation of North Central Massachusetts awarded \$25,000 (see sidebar for grants) to 10 food pantries.

The Foundation provided matching grants, so it would give the agencies an additional marketing tool to encourage donors to make matching gifts.

"We wanted to leverage our grants dollars during what is typically a slow fundraising period for many food pantries, said Phil Grzewinski, president of the Community Foundation of North Central Massachusetts. "It was a great success; the agencies were able to raise over \$70,000 during the month of April."

Grants

Community Foundation of North Central Massachusetts makes a series of new grants from its general endowment





The Community Foundation of North Central Massachusetts announced 18 grants of nearly \$280,000 from its general endowment and a field of interest fund during the fiscal year.

Fitchburg State University and Mount Wachusett Community College each received \$50,000 for scholarships.

Students enrolled in Fitchburg State's LPN (Licensed Practical Nurse) to BSN (Bachelor of Science in Nursing) programs will be eligible to apply for scholarships that would pay up to 75% of the direct costs for school after applications of the Pell Grant.

The community college will provide scholarships to students enrolled in its Advanced Manufacturing or Biotechnology programs, in addition to certificate programs for career improvements.

America's Youth Teenage Unemployment Reduction Network of Brockton received \$15,000 for its Fitchburg GED Plus Program, which helps youth prepare for their GED.

To help mitigate the closing of a nearby childcare center, a \$12,000 grant was given to Applewild School for its Child Development Center, which provides preschool childcare.

The Center for Human Development, Inc. in Orange was awarded a \$4,000 grant to train 15 clinicians in substance abuse counseling.

Thayer Symphony Orchestra, Inc. of Leominster received a \$15,000 grant for The Music Connection, which is focused on revitalizing music education in Fitchburg and Leominster fourth-grade classes.

The City of Leominster's \$6,500 grant will be used to reopen the Leominster Art Center downtown.

Youth Opportunities Upheld, Inc. of Worcester will use its \$9,000 grant to expand its prevention specialist position for the Gardner Family Center.

Literacy Volunteers of the Montachusett Area was awarded \$25,000 to develop strategic succession planning.

A \$5,000 grant to Montachusett Interfaith Hospitality Network of Fitchburg will be used for professional development of the network director and board of directors

United Neighbors of Fitchburg, Inc. was awarded \$4,800 to provide software training for the staff.

Young Entrepreneurs Society, Inc. of Orange received a \$10,000 grant for capacity building during the hiring of a new executive.

The Ashburnham Conservation Trusts, Inc. received a \$500 mini-grant to support its annual meeting.

A \$15,000 grant was given to **Growing Places Garden Project, Inc.** of Clinton, to recruit and train gardeners who will support current projects in low-income neighborhoods of Fitchburg.

The Massachusetts Audubon Society was awarded a \$7,180 grant for its science education program, which provides workshops for third- and fourthgrade teachers in Gardner and Fitchburg.

Twin Cities Community Development Corporation's \$15,000 grant will be used to market its neighborhood revitalization efforts on Elm Street.

Squannacook Greenways Inc. received an \$18,000 grant to support the initial planning stages of the River Rail Trail project in Townsend.

An \$18,000 grant went to **The Trustees of Reservations** to make the trails at the Doyle Community Park in Leominster accessible for those with mobility impairments.



Nashoba Community Health Care Fund awards grants to help improve the health of local communities







The Community Foundation of North Central Massachusetts and the Greater Lowell Community Foundation awarded 14 grants to help improve the health of residents in 13 communities in the region.

Advocates, Inc. of Ayer received a \$5,000 grant to cover co-payments for counseling services needed by underinsured or uninsured clients.

A \$7,500 grant to the Boys & Girls Club of Lunenburg will fund its after-school program for Lunenburg students, called Triple Play: Healthy Minds, Bodies, and Souls

Community Healthlink of Worcester was granted \$5,671 for its 10-week parent-child early intervention education program for parents in the Nashoba Valley region.

A music therapy outreach program, by Indian Hill Music in Littleton, received an \$8,500 grant to improve the quality of life for individuals by addressing emotional, physical, cognitive and social needs through music.

A \$5,250 grant to Cooperative Elder Services of Groton will address the need for improved access to preventive healthcare services for isolated elders.

Deven's Loaves & Fishes Food Pantry received a \$20,000 grant for food.

The Lura A. White Elementary School in Shirley received a \$17,425 grant for a gardening education program at the school.

MAB Community Services of Brookline received a \$2,500 grant to improve the ability of patients with limited eyesight in Nashoba Valley to conduct daily living activities.

A \$5,000 grant to Lancaster-based Nashua Valley Council, Boy Scouts of America, will provide support for its summer camp.

A new greenhouse and a hydroponics program will be created by North Middlesex Community Garden in Townsend through its \$20,000 grant.

Our Father's House in Fitchburg received \$16,000 for the "Transitions at Devens" program, which will provide access to healthcare for homeless children.

The Shirley Council on Aging will use a \$4,600 grant to conduct health fairs for seniors.

An \$11,600 grant to the **Townsend Council on Aging** will be used for its senior meal program.

The Townsend Police Department will reinstitute its DARE program for fifthgrade students as a result of a \$7,449 grant.

The grant dollars awarded come from the Nashoba Valley Community Healthcare Funds, which are managed respectively by both Community Foundations. The funds were established in 2006 from the sale proceeds of the nonprofit Deaconess-Nashoba Hospital to Essent Healthcare, which created Nashoba Valley Medical Center.

A variety of new funds were established during the year.

These funds will benefit the community forever and create a lasting legacy for the donors and their families.

How donors can make a difference

Donor Funds are convenient, flexible tools for individuals, families, businesses, or groups that want to be personally involved in suggesting grant awards made possible by their gifts.

Unrestricted Fund. Community Foundation of North Central Massachusetts General Endowment (2001) - This and the regional endowment funds have been established to respond to a wide range of community needs. The flexibility of your unrestricted gift enables your community foundation's program experts to respond to the community's most pressing needs, today and tomorrow. In addition, donors can target their gift to a specific region that can accept gifts of any size.

Donor Advised Funds. You can have ongoing involvement in the use of your gift. You work with our professional program staff, identifying ways to use dollars from the Donor Advised Fund you establish to address the issues and needs you care about most. Your recommendations are submitted to our local board for approval; we then distribute grant dollars.

Field of Interest Funds. You can target your gift to address needs in an important area of community life. Arts. AIDS. Aging. At-risk youth. You identify your personal interest area when making your gift; our board awards grants to community organizations and programs that are making a difference in the area you select.

Scholarships. You can invest your gift in our community's future and show students you care, all with the guidance and personal services of your community foundation. You determine the criteria students must meet to receive the Scholarship you establish. With your assistance, students achieve their academic and career-oriented goals—from preschool to postgraduate work.

Designated Funds. You can direct your gift to a specific nonprofit organization or purpose. Help provide ongoing funding for a senior center, museum, or virtually any nonprofit charitable organization. Nonprofit organizations can use a Designated Fund through the community foundation to build their endowment and enhance their ability to accept large and complex gifts.

Agency/Non-Profit Funds. An agency/nonprofit endowment is a simple and efficient way to build an income for your nonprofit organization. We set up a special fund in the name of your nonprofit organization. Your board determines how much you would like to invest long-term. Each year your organization receives a distribution from the fund, creating a permanent source of income.
